

REQUEST FOR A "SPECIAL MEETING" OF THE STONEBRIDGE COURT HOA

The purpose of this meeting will be to discuss the Overland Park Proposed Zoning Change *159th St.* recently approved by the Planning and Zoning Commission for land at approximately *162nd* and Antioch.

The question remains whether:
